37th IARIW General Conference

The 37th IARIW General Conference hosted by the National Statistical Institute of Luxembourg (STATEC) took place in-person in Luxembourg August 22-26, 2022. A total of 120 papers were presented in plenary, parallel and poster sessions, with 174 delegates from 32 countries. The IARIW Membership Meeting that was held on August 23 in Luxembourg. At the meeting, reports from the Executive Director, Treasurer, and *Review of Income and Wealth* editors were presented. 2024 General Conference

The 38th IARIW General Conference will take place in England in August 2024. The Association thanks the Economic Statistics Centre of Excellence (ESCoE) for agreeing to host the conference. The Council has decided on six general themes for the conference, namely reforming the SNA, natural capital and the green economy, productivity and innovation, poverty, and inequality dynamics, measuring income and wealth distributions, and well-being measurement.

The formal call for papers for the conference will be released in February 2023, with the submission portal open shortly thereafter. The deadline for proposals for papers is August 31, 2023.

Special IARIW-TNBS Conference on Income, Wealth, and Well-being in Africa

The IARIW, in partnership with the Tanzania National Bureau of Statistics, held the special conference "Measuring Income, Wealth, and Well-being in Africa" in Arusha, Tanzania, November 11-13, 2022. This was the first conference that the IARIW has organized in East Africa. The conference brought together academics, statisticians, policymakers, and other data users interested in the measurement of income, wealth, and well-being in an African context. A total of 125 delegates attended the conference with representation from 23 countries. A total of 35 papers were presented and can be accessed at https://iariw.org/iariw-tnbs-conference-program/

Selected papers from the conference will be published in a supplementary issue of the *Review of Income* and *Wealth* edited by Lars Osberg from Dalhousie University and Hai-Anh Dang from the World Bank.
