IARIW-CIGI Conference on the Valuation of Data

In collaboration with a Canadian think tank, the Centre for International Governance Innovation (CIGI), the IARIW has organized a conference on “The Valuation of Data” which will take place in Waterloo, Ontario, Canada, November 1 to November 4, 2023. The objective of the conference is to advance our understanding of methodologies used to estimate the value of data. A total of 24 research papers will be presented at the conference. Changes to IARIW-Wiley Contract Related to the Cessation of Production of the Printed Version of the Review of Income and Wealth

The IARIW contracts the Oxford-based publishing firm Wiley to publish and distribute the Review of Income and Wealth. A new contract will begin on January 1, 2024. A major change in the contract is that starting with the March 2024 issue, Wiley will no longer produce hard copies of the Review of Income and Wealth. This will only affect the approximately one fifth of individual members who continue to receive the hard copy. For the small number of persons who receive a

hard copy of the journal and have pre-paid their memberships for 2024 and later years, an adjustment will be made to their membership renewal date. It will still be possible for members to receive the Review of Income and Wealth in hard copy format, but there will be an additional charge.
