Dear Paper Giver at the 38th IARIW General Conference,

The deadline for the regular registration for the 38th IARIW General Conference is July 14, 2024. Papers givers are encouraged to register by this date to avoid the late package fee of 50 pounds sterling. This event, co-organized with the Economic Statistics Centre of Excellence (ESCoE), will take place at King's College London (Strand campus) from the evening of Monday, August 26 to Friday, August 30, 2024. Papers givers do not have to join the IARIW to participate in the conference, but do have to pay the non-member registration fee, which is £100 higher than the member rate. discussant. A number of poster papers are transferred to the regular session to replace withdrawn papers. Session organizers need the full paper for decisions on which papers to transfer.

Ruggles Prize

Paper givers under the age of 35, including authors in the poster session are encouraged to have their paper considered for the Richard and Nancy Memorial Prize for best paper presented at the General Conference by a young researcher. The value of the prize is \$2,500 US. The paper must be submitted to me at info@iariw.org by July 31, 2024.
